A fourth strategic planning work session of the Board of School Trustees was called to order at 5:35 p.m. by Mrs. Shuey. Board members present were Mrs. Shuey, Mr. Stanton, and Mr. Wagner. Also present were Mr. Watkins, Mr. Hanson, Mr. Hall, Mr. Cary, Mr. Frye, Ms. Spiker, Mr. Hahn, Mr. Mullett, Mr. Badry, and Mr. Adamson.

STRATEGIC PLANNING

Mr. Adamson started the meeting by reading the belief and/or value statements rewrite.

Peru Community Schools Believes:

- All students, staff and parents share responsibility for student achievement.
- Each child has worth and will achieve in an environment where they feel loved, supported, challenged, and valued.
- Students achieve their maximum potential in a school that accommodates their social, physical, intellectual and emotional development abilities and interests.
- In engaging students in rigorous, data-driven and standardsbased curricula that enable students to excel in their community and within a global economy.
- Community support and collaboration are vital for the success of the school corporation.
- Technology is a tool that benefits students and employees, improving efficiencies throughout the corporation.

- A school culture that models and affirms positive behavior.
- Digital Literacy as a key component of the K-12 curricula. Continuous, professional development for all personnel.

He divided the group into two smaller groups to gather their thoughts. When the group reconvened they discussed their ideas and agreed upon a vision.
