May 15, 2023

The regular meeting of the Board of School Trustees was called to order at 6:43 p.m. by Dr. Quin. Dr. Quin led the Board and audience in the Pledge of Allegiance. All Board members were present. Also present were Mr. Watkins, Mr. Durrwachter, Mrs. Sheets, Dr. Cole, Mr. Morris, Chuck Hight, Mr. Polk, Mrs. Martino, Nancy Mitchell, Mrs. Forman, Danny Harmon, community members, and PCS legal representation.

On motion by Dr. Rogers, seconded by Mr. Beattie, the Board 7-0 unanimously approved the public agenda with one change: addition IV.I.13.

On motion by Ms. Justice, seconded by Mr. Mullett, the Board approved the memorandums of April 5, 13, and 17, 7-0 with one correction. Adding Public to the name Peru Library Board that was stated.

- II. BLACK AND GOLD AWARDS/RECOGNITIONS Mr. Watkins presented Mrs. Kim Martino an award along with a personalized tiger statue for her 27 years of service as she retires from Elmwood as a reading specialist. Nancy Mitchell an award along with a tiger blanket for her 22.5 years of service as she retires from Elmwood kitchen.

III. AGREEMENTS AND CONTRACTS

A. PERMISSION TO ACCEPT BID FOR PCS PARKING LOT LIGHTS - Mr. Durrwachter requested to accept a bid from the bids that were received for new parking lot lights for the corporation. Central Lighting was recommended by those bids. Central Lighting is a local company, our maintenance department has worked with them for many years, they are familiar with our parking lots, and its electrical footprint. The Peru Jr/Sr High School, Junior High, and Elmwood parking lot lights will be upgraded to LED. They will put up poles, run electric and install LED lights on the west side of Blair Pointe. Wall pack lights are Peru Junior Senior High and running electric by doors 5,7,13, and 17.

On motion by Mr. Beattie, seconded by Dr. Rogers, the board voted 7-0 to accept the bid for Central Lighting to install new PCS Parking lot lighting.

B. PERMISSION TO ACCECPT BID FOR NEW PLOW TRUCK - Mr. Durrwachter requested to accept a bid from the bids that were received for the new plow truck. Paul Richards was recommended from the bids that were received.
